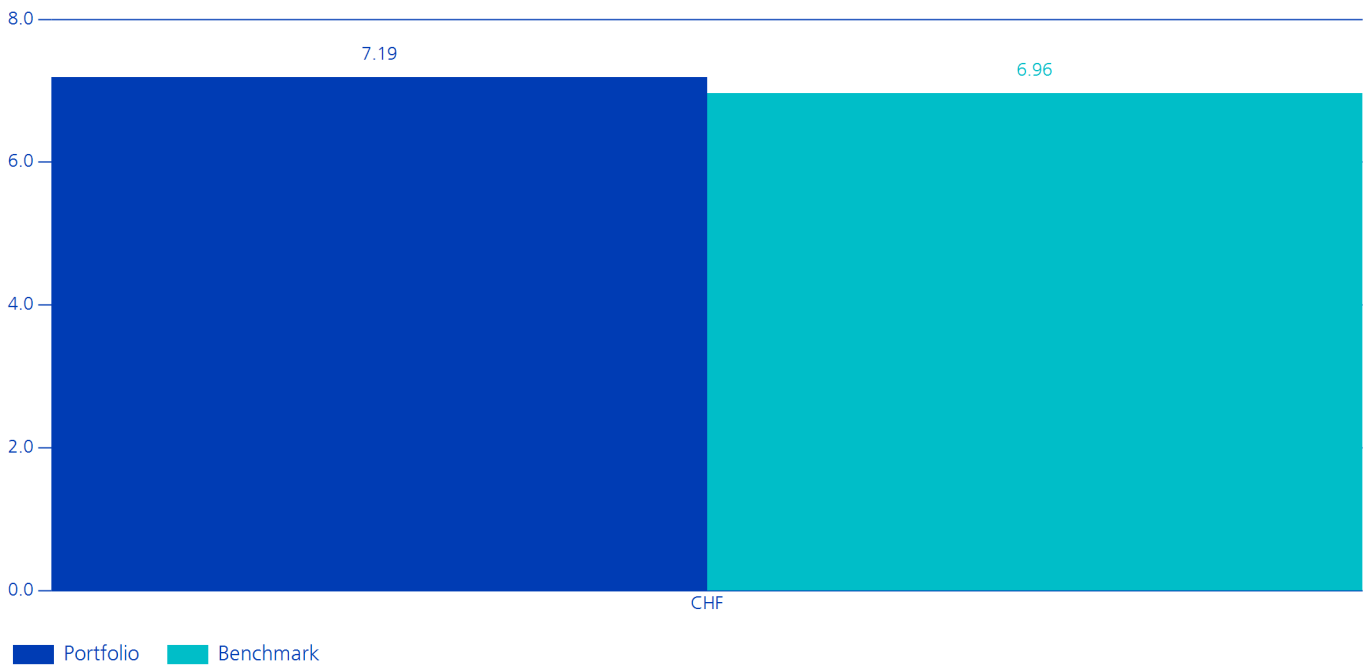

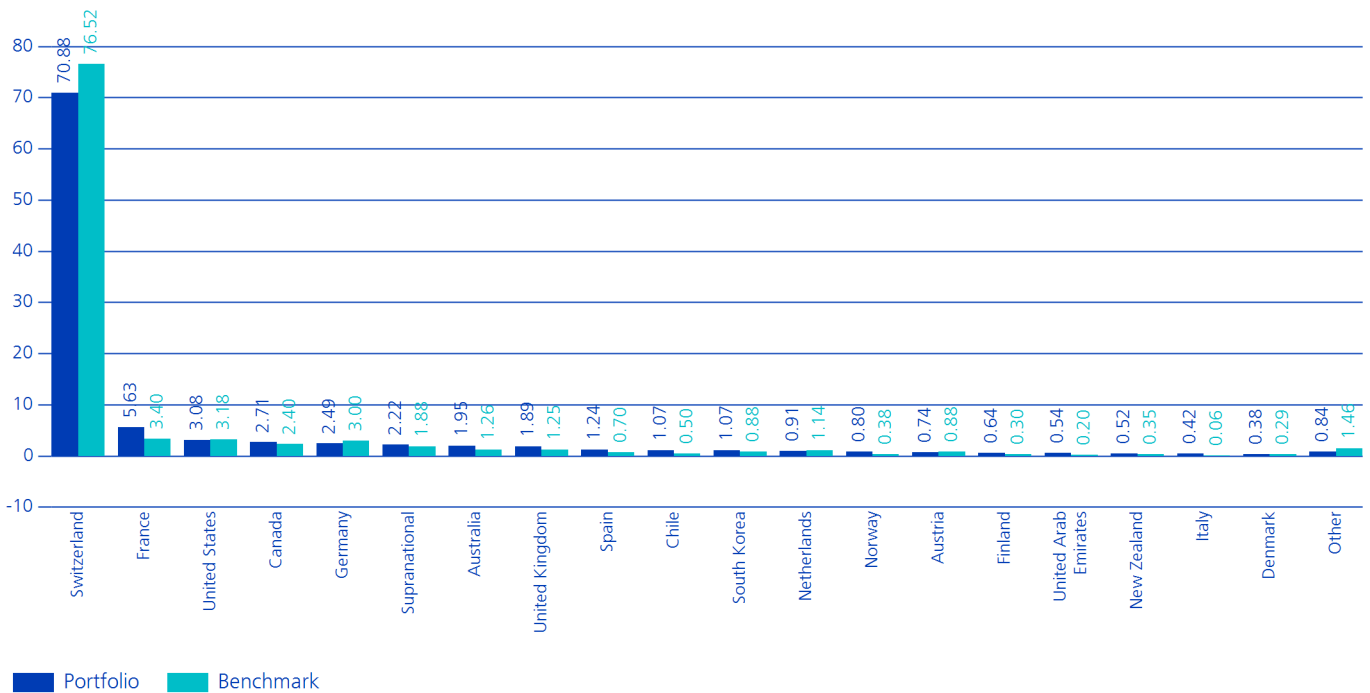
### 7.1.2 Rating Breakdown in %



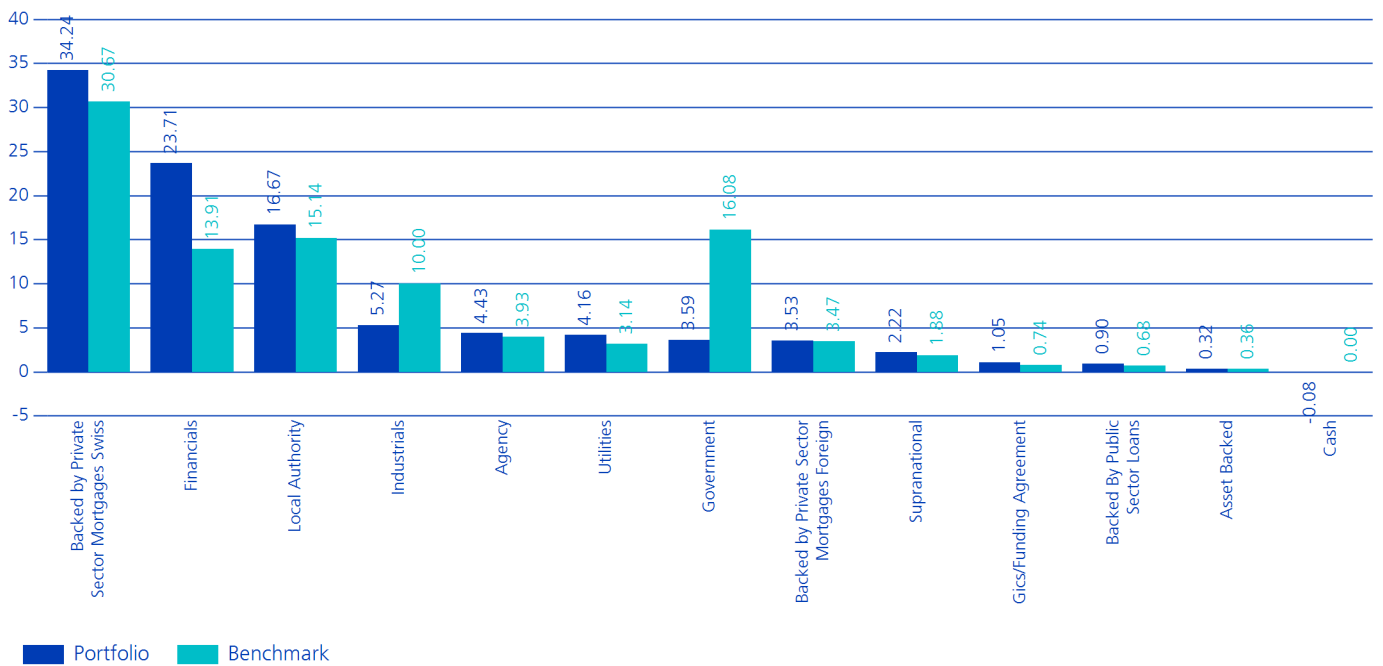
### 7.1.3 Modified Duration

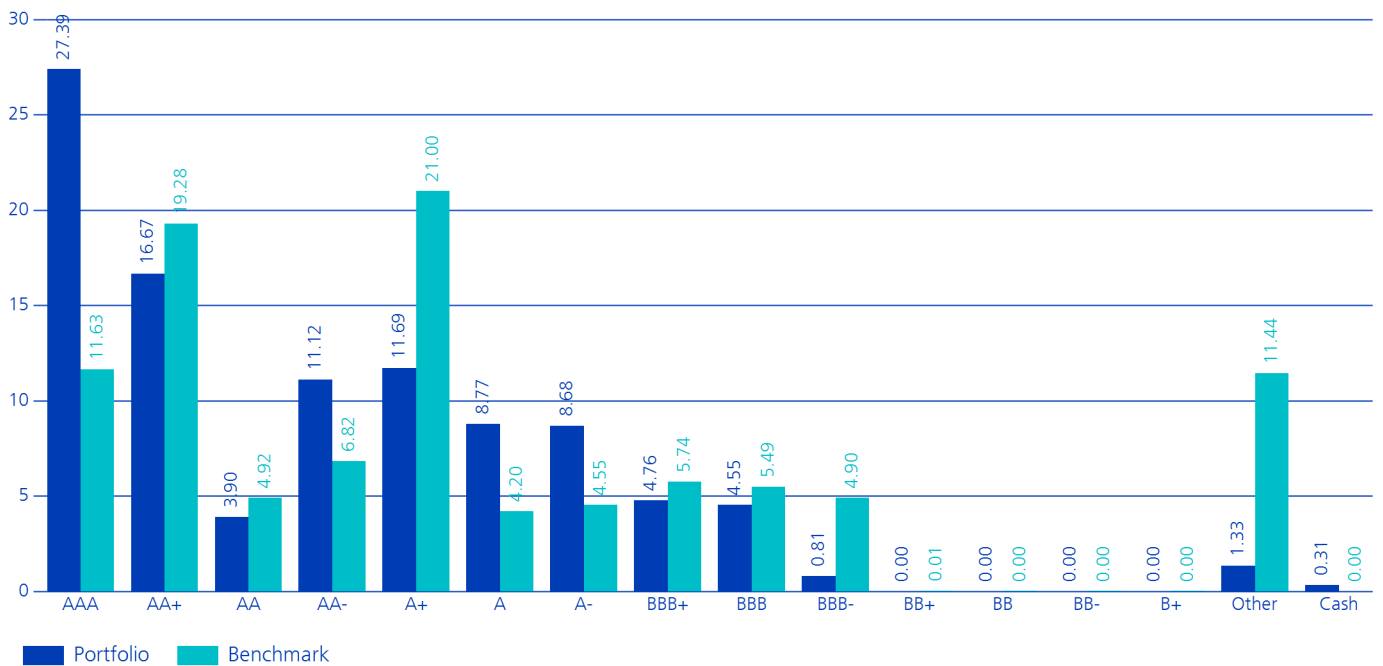


### 7.1.5 SBI Sector Level 3 in %

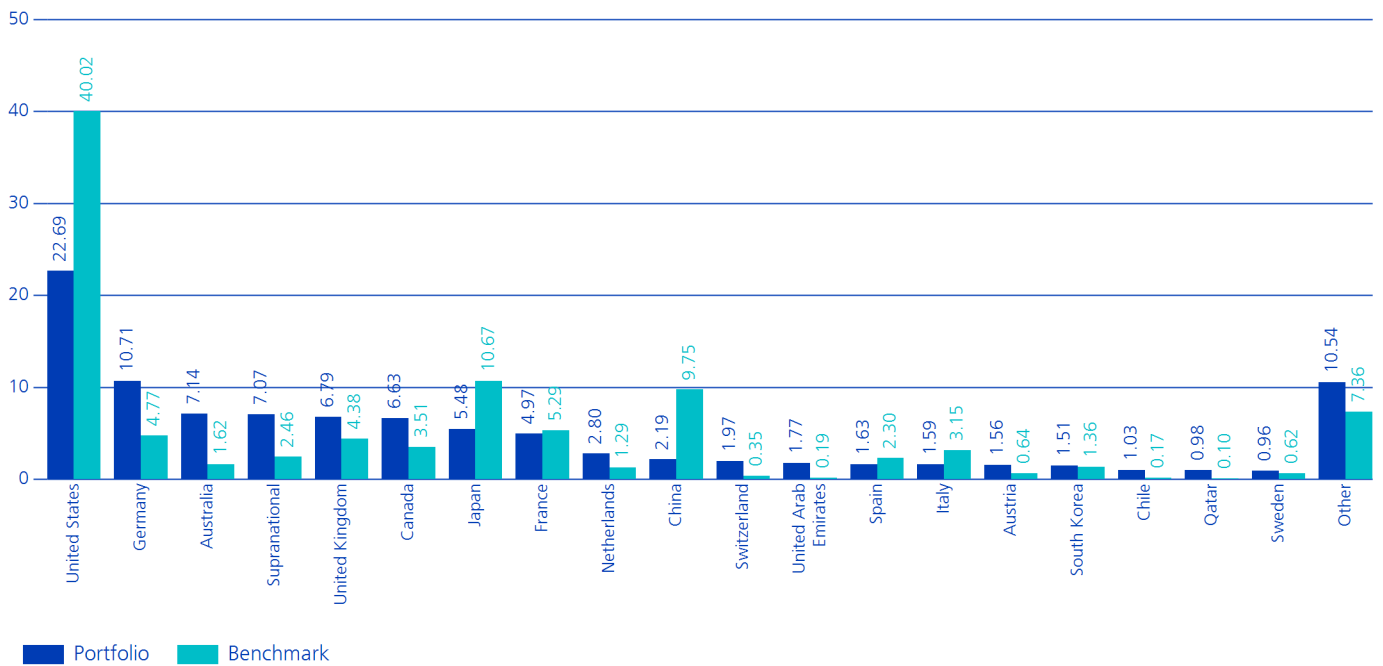

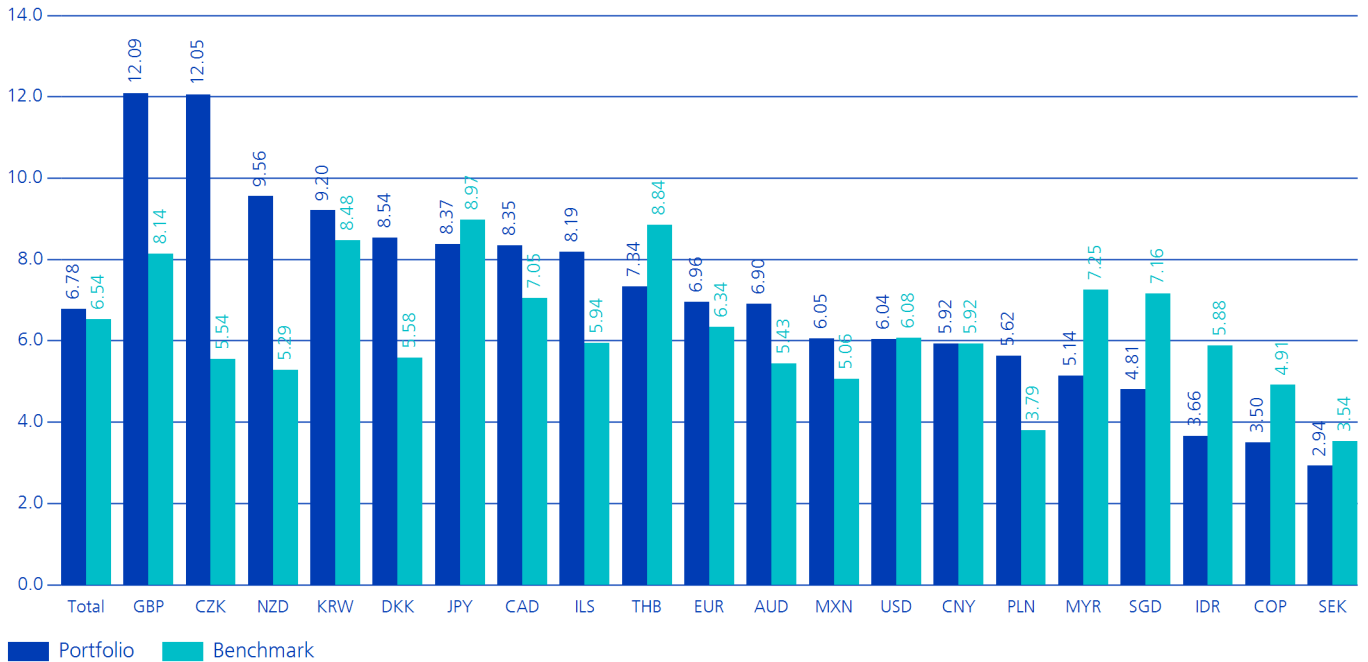

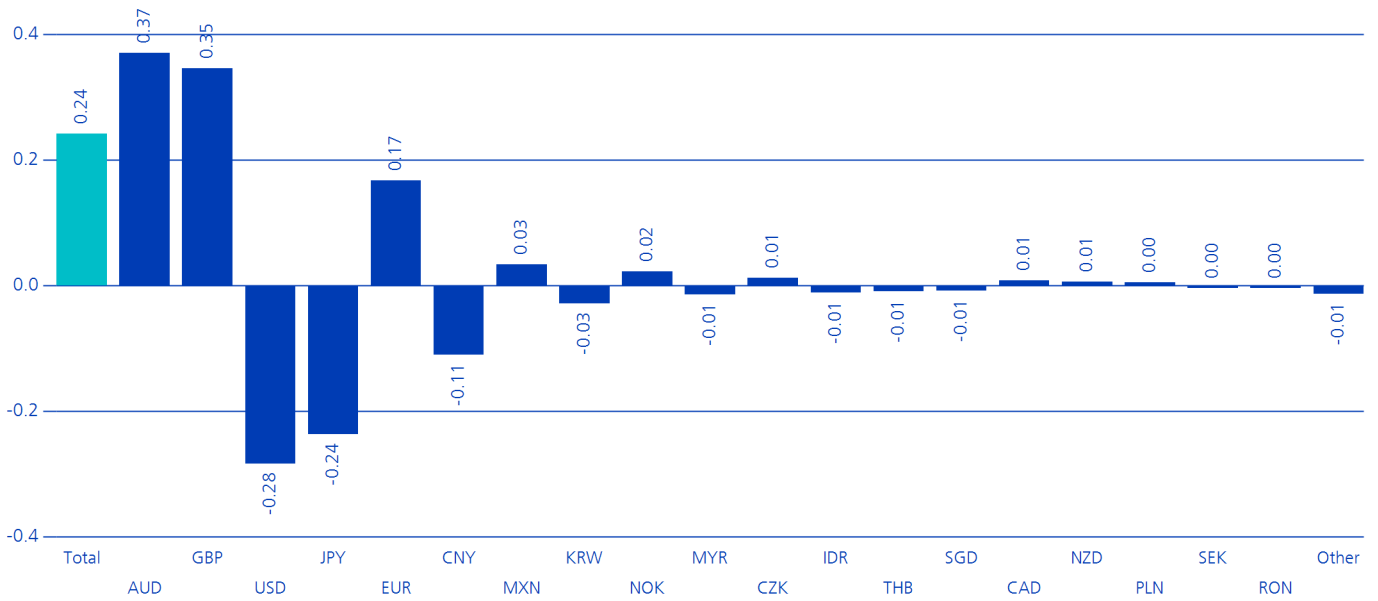

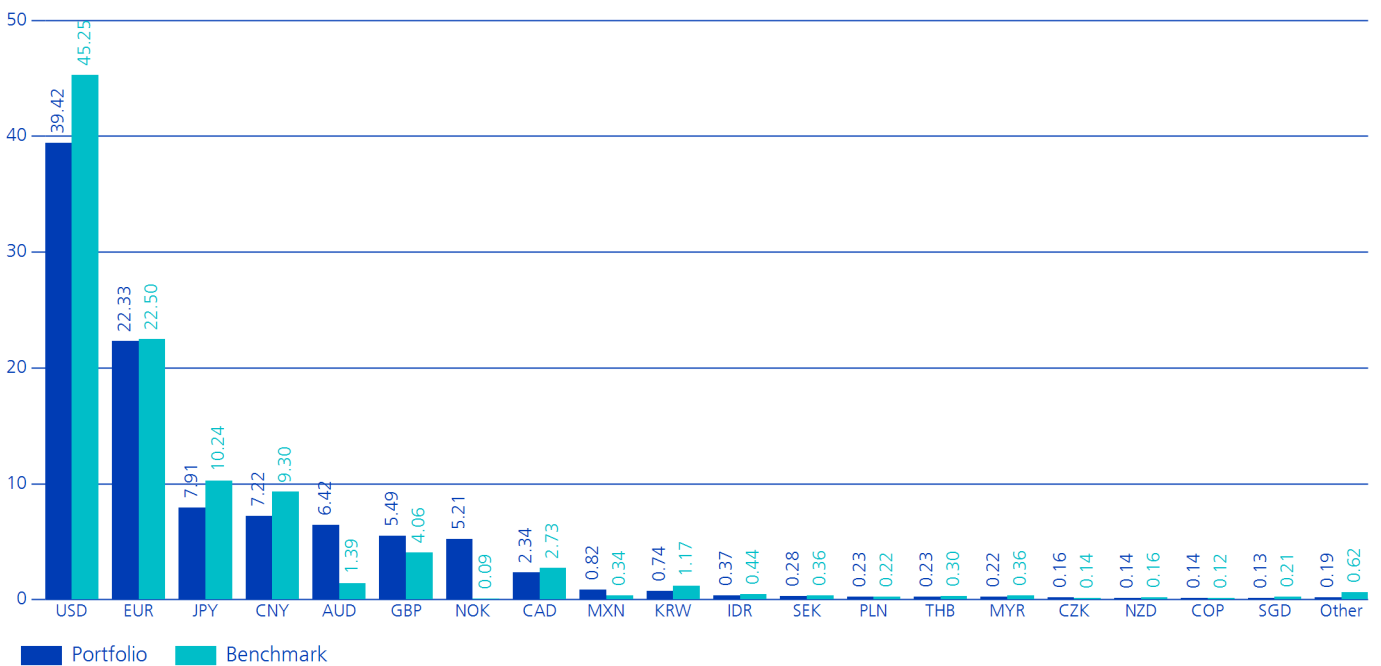
## 7.2.3 Modified Duration per Currency



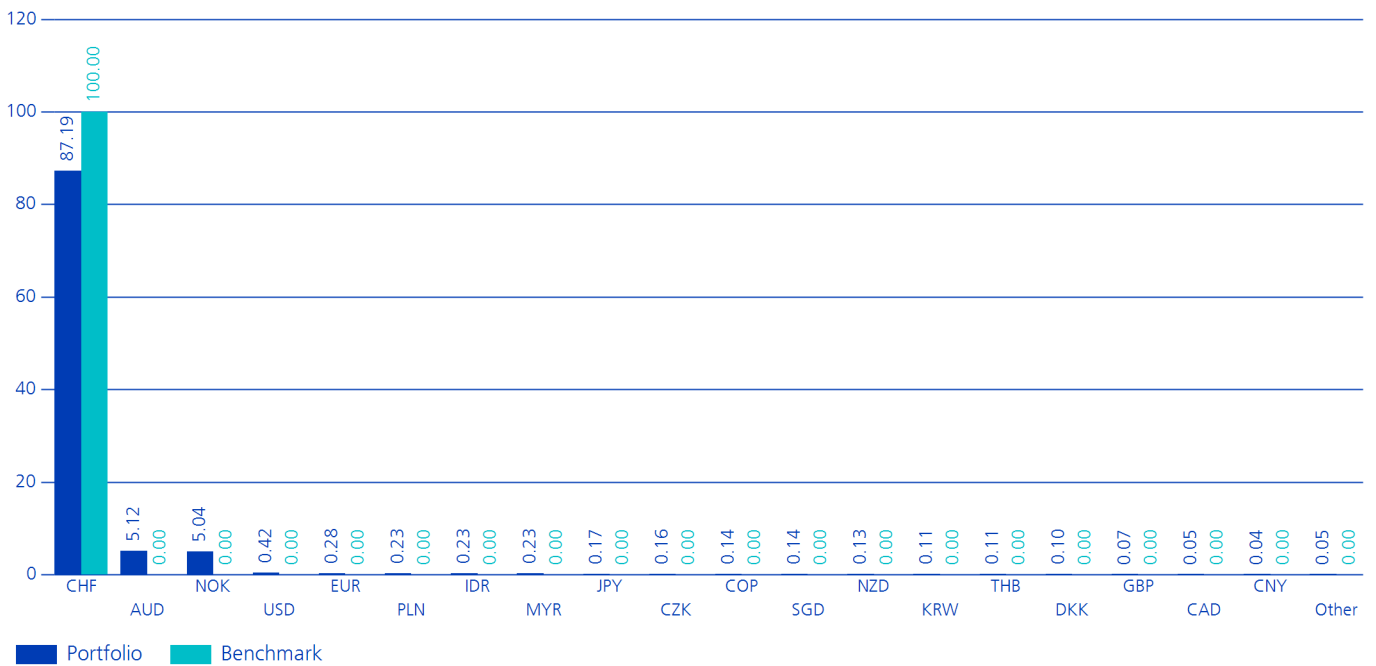
## 7.2.4 Modified Duration Exposure per Currency



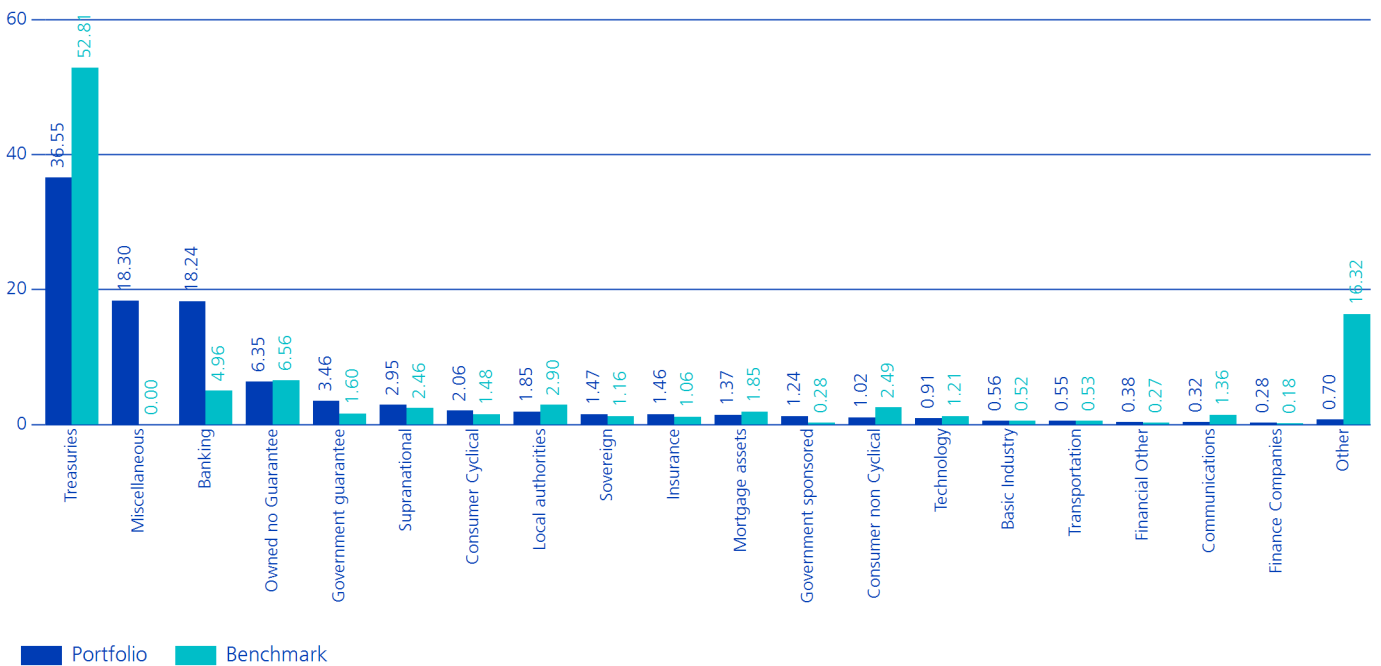

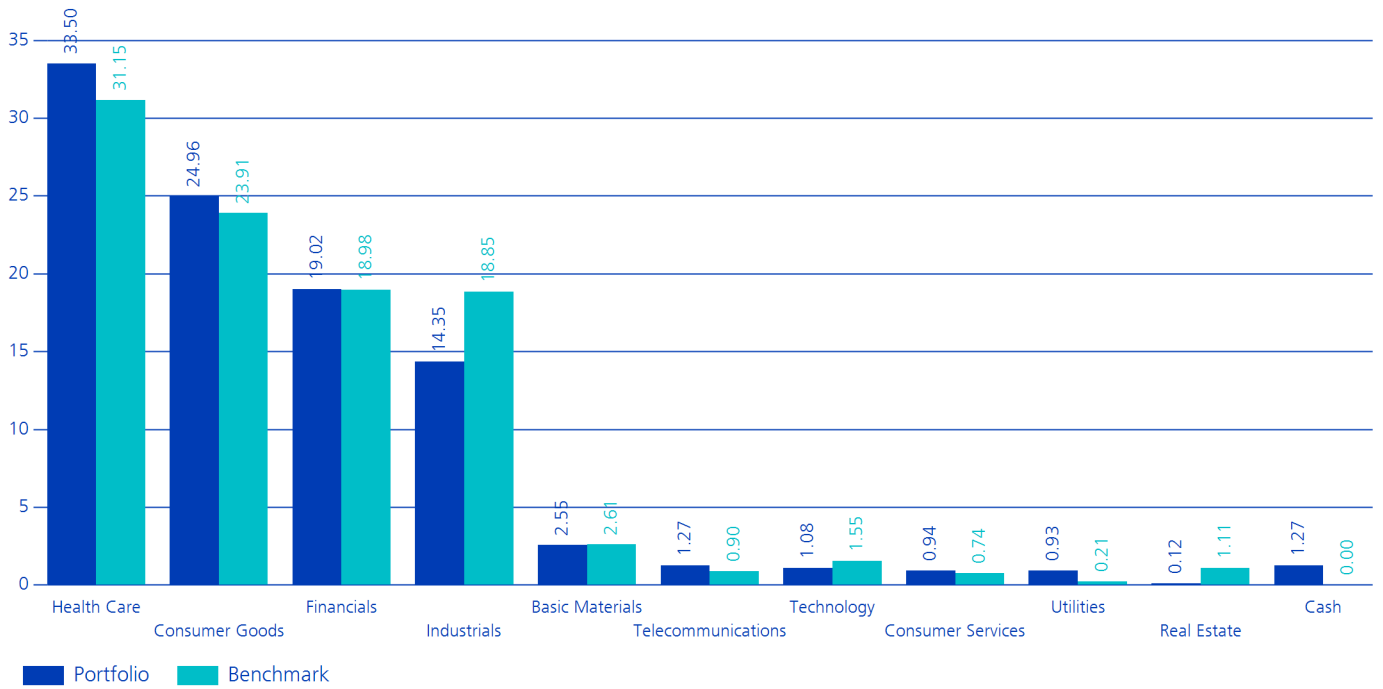

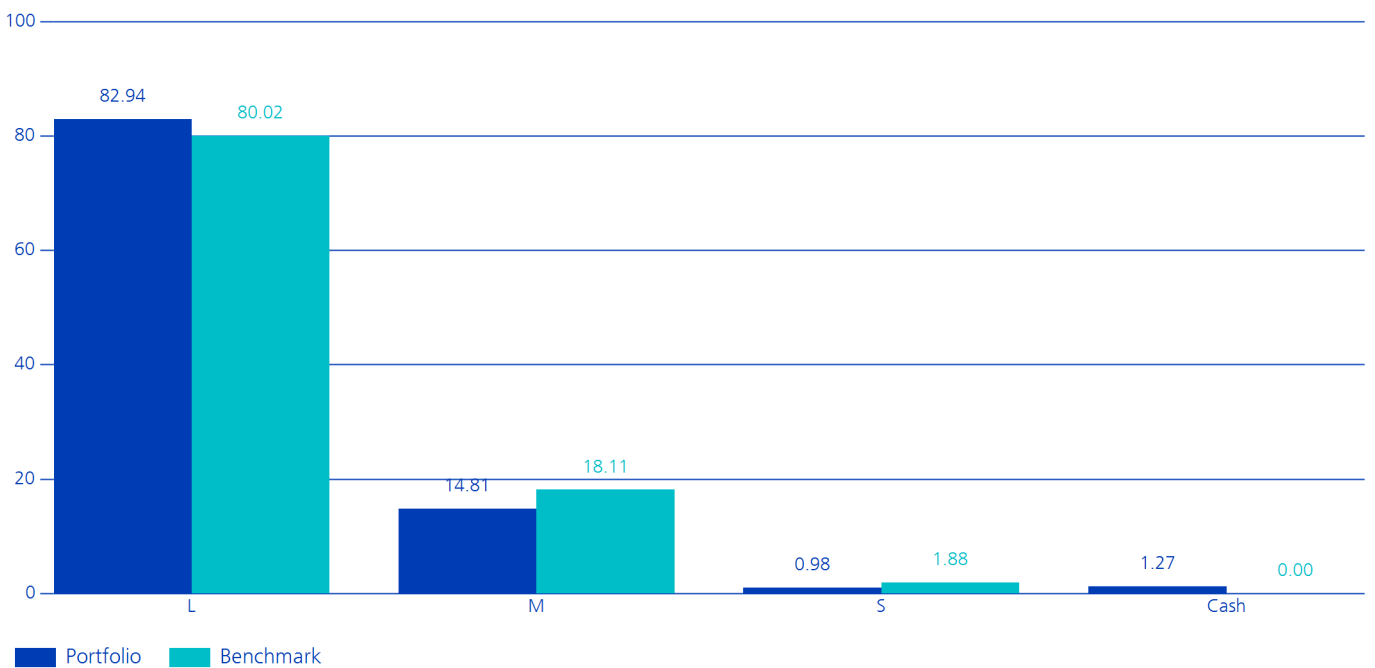

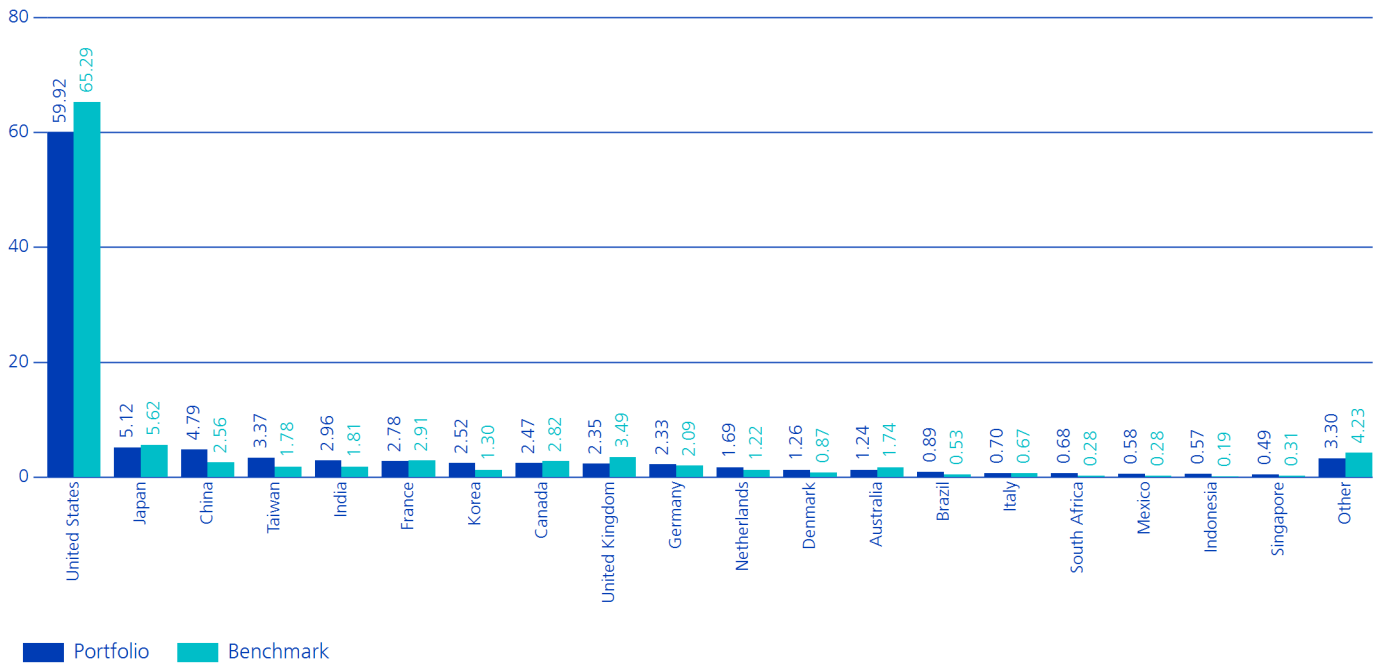

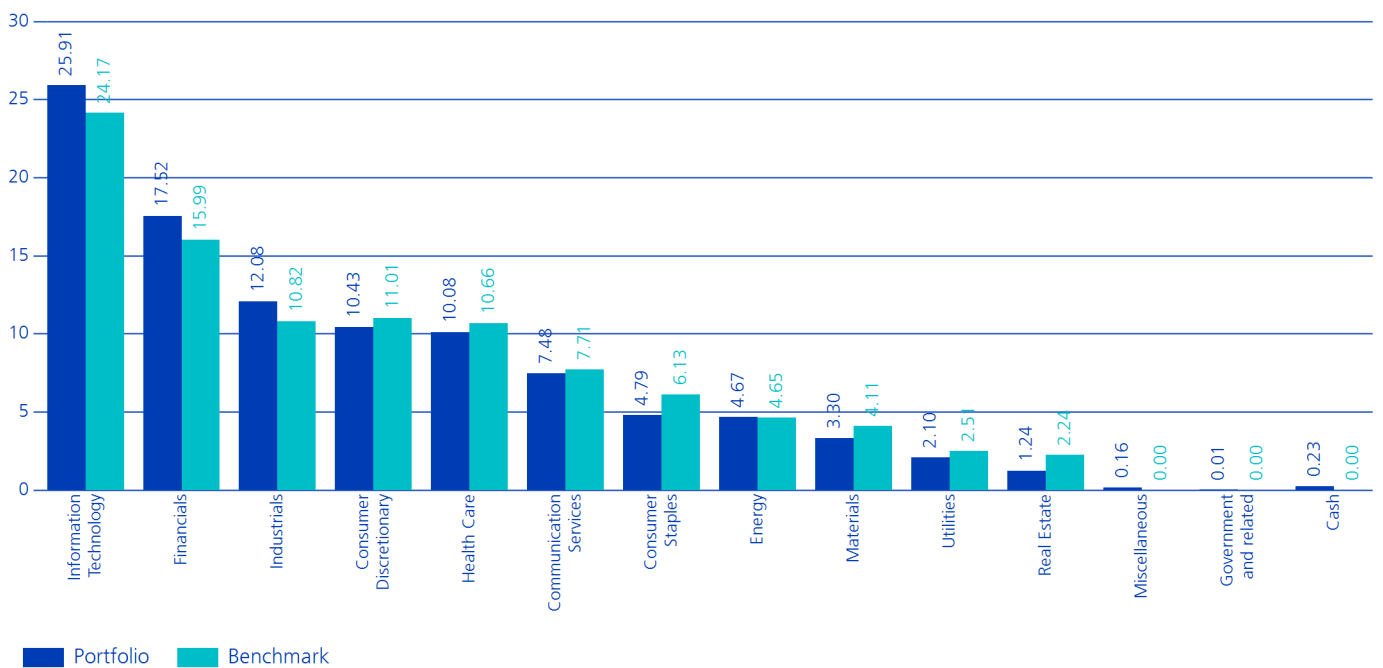

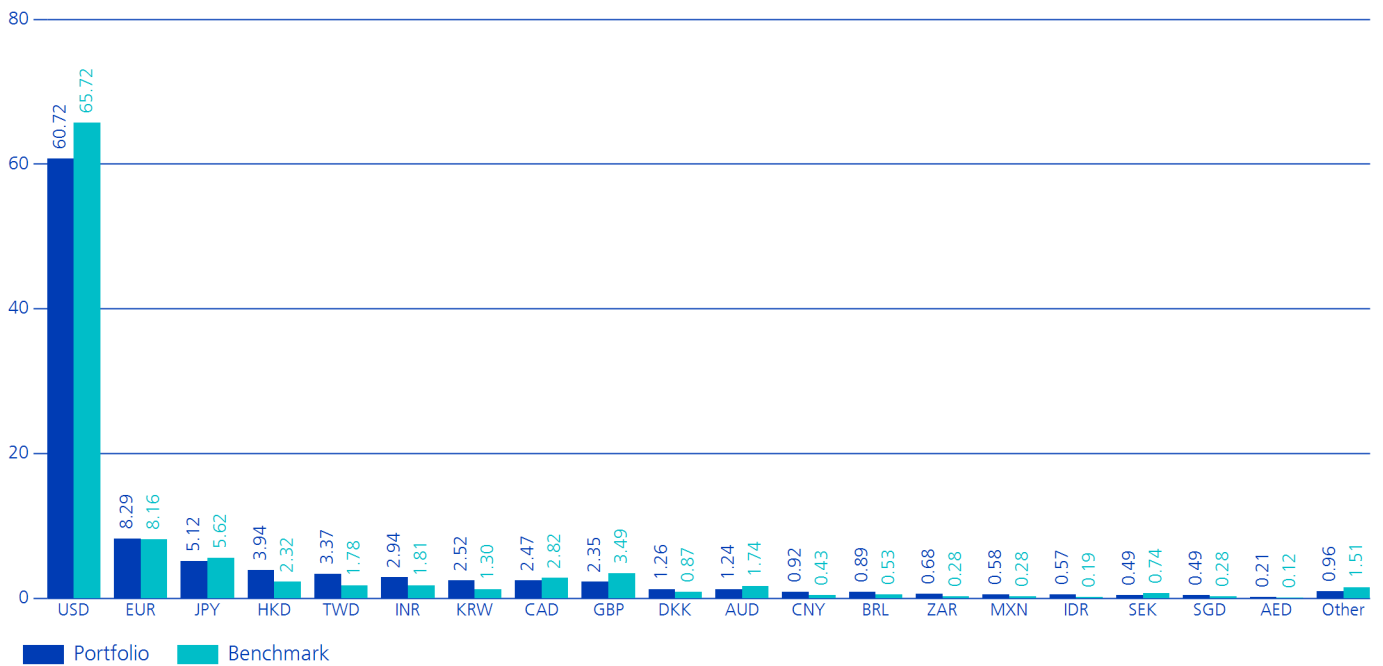
### 7.4.1 Country Breakdown (Country of risk) in %



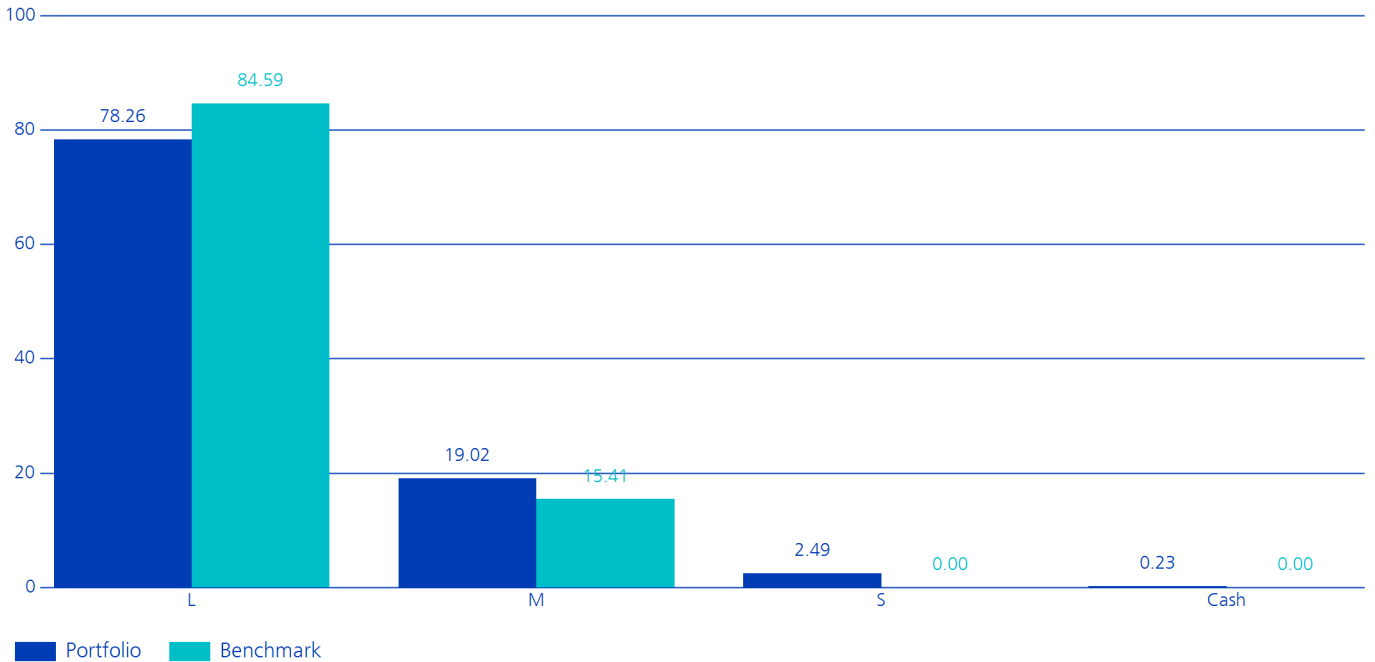
### 7.4.2 GICS Sector in %
